A RESOLUTION CERTIFYING LOCAL GOVERNMENT ENDORSEMENT OF KOPPERS INC. TO PARTICIPATE IN THE TAX BACK PROGRAM AS AUTHORIZED BY SECTION 15-4-2706(D) OF THE CONSOLIDATED INCENTIVE ACT OF 2003; AND FOR OTHER PURPOSES.

WHEREAS, in order to be considered for participation in the Tax Back Program, the local government must endorse a business to participate in the Tax Back Program and authorize the refund of local sales and use taxes as provided in the Consolidated Incentive Act of 2001; and

WHEREAS, said endorsement must be made on specific form available from the Arkansas Department of Economic Development; and

WHEREAS, Koppers Inc., 436 Seventh Avenue, Pittsburgh, Pennsylvania 15219, has sought to participate in the program and more specifically has requested benefits accruing from the design, installation, and start-up of a new facility located on existing land within the current treatment site at 2201 Edmonds Street, in the City of North Little Rock; and

WHEREAS, Koppers Inc. has agreed to furnish the local government all necessary information for compliance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Koppers, Inc. is hereby endorsed by the City Council of North Little Rock, Arkansas for benefits from the sales and use tax refunds as provided by Section 15-4-2706(d) of the Consolidated Incentive Act of 2003.

SECTION 2: That the Department of Finance and Administration is authorized to refund local sales and use tax to Koppers Inc.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
