A RESOLUTION APPROPRIATING ADDITIONAL FUNDS TO COMPLETE THE PROJECT FOR SIDEWALKS AND OTHER IMPROVEMENTS LOCATED AT 700 BROADWAY; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to Resolution No. 9032, adopted July 25, 2016, the North Little Rock City Council appropriated \$75,000.00 for construction of sidewalks and other public improvements at or near the Orbea USA LLC facilities located at 700 Broadway in the City of North Little Rock (the “City”); and

WHEREAS, pursuant to the City Engineer, the following work has been completed by the two contractors who were selected to perform the job:
