A RESOLUTION ACCEPTING THE LOW BID OF REDSTONE CONSTRUCTION GROUP FOR THE GOLF CART COURSE REHABILITATION PROJECT AT NORTH LITTLE ROCK BURNS PARK; APPROPRIATING FUNDS; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock ("the City") has advertised for bids for the Golf Cart Course Rehabilitation Project at the Burns Park Golf Course (Bid Summary No. 16-3417) attached hereto as Exhibit "A"); and

WHEREAS, the low bidder for the project was Redstone Construction Group of Little Rock, AR with a bid of \$211,850.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the low bid of Redstone Construction Group for the Golf Cart Course Rehabilitation Project at North Little Rock Burns Park Golf Course in the amount of \$211,850.00 is hereby accepted.

SECTION 2: That all contracts and related documents necessary to effectuate work on the project by Redstone will be reviewed and approved by the Office of the City Attorney prior to execution thereof.

SECTION 3: That the amount of \$211,850.00, plus such amount as may be required for sales tax or necessary change orders up to 20%, is hereby appropriated from the Parks and Recreation Capital Improvements Fund.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.


