

AN ORDINANCE CHANGING THE NAME OF A PROPOSED PORTION OF COUNTRY CLUB PARKWAY IN THE CITY OF NORTH LITTLE ROCK TO MILLIGAN DRIVE; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the City Council has the power to change the names of streets within the city limits when deemed necessary; and

WHEREAS, a request has been made to change the name of a proposed portion of Country Club Parkway located in the northwestern portion of the City of North Little Rock (“the City”) to Milligan Drive (see Petition attached hereto as Exhibit “A”); and

WHEREAS, the alignment of Country Club Parkway has been changed by the City of Maumelle and the proposed portion of Country Club Parkway located in North Little Rock will no longer be on that alignment; and

WHEREAS, in order to avoid confusion in the future regarding this roadway, the current proposed portion of Country Club Parkway located in North Little Rock should be given a new name; and

WHEREAS, the Planning staff approve the subject renaming, and since this is a *proposed* street, changing the name will not affect the City’s Emergency Services or Fire and Police Departments.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the proposed Country Club Parkway, located in the northwest portion of the City is hereby renamed as proposed Milligan Drive (see map attached hereto as Exhibit “B” and incorporated herein by reference.)

SECTION 2: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 3: That the Street Department is hereby directed to make changes as needed to make this ordinance effective.

SECTION 4: That the City Clerk is hereby directed, as needed, to mail a copy of this Ordinance and map to the North Little Rock Police, Fire and Emergency Services Departments and the United States Post Office.

SECTION 5: It is hereby found and determined that the renaming of the proposed portion of Country Club Parkway in the City to the proposed Milligan Drive,

as provided for herein, is immediately necessary in order to insure the proper and orderly development of the City of North Little Rock and being necessary for the immediate preservation of the public health, safety and welfare; THEREFORE, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.





