**AN ORDINANCE GRANTING A SPECIAL USE TO ALLOW A DAYCARE CENTER IN AN R-3 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 1217 WEST 22<sup>ND</sup> STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.**

WHEREAS, application was duly made by Ms. Tureana Smith-Johnson, 10930 Frenchman Loop #B, North Little Rock, AR 72113, seeking a special use of said land, which application was duly considered and approved (8 affirmative votes; 1 abstain) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof held on May 12, 2015.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That a special use is hereby granted to allow a daycare center in a C-1 zone for the subject real property located at 1217 West 22<sup>nd</sup> Street in the City of North Little Rock, being more particularly described as:

Lot C, Block 5, Coor's Addition to the City of North Little Rock, Pulaski County, Arkansas. (See Exhibits "A" and "B" attached hereto.)

SECTION 2: That this special use shall be subject to the conditions listed below:

- a) Applicant must meet all applicable Federal, State, County and City requirements.
- b) Hours of operation will be Monday-Friday, 6:00 a.m. to 6:00 p.m.
- c) Playground to meet Arkansas Department of Human Services and City of North Little Rock requirements for playground surface and equipment.
- d) Playground fence to be six-foot (6') wood privacy fence.
- e) Playground to be directly accessed from the building.
- f) Playground to have an emergency exit away from the building.
- g) Business license to be issued after Planning Staff confirmation that requirements have been met.
- h) Applicant/owner understands that failure to comply with these conditions may result in loss of the Special Use and/or removal of Electric Power Meter.
- i) All daycare centers/home daycares shall perform a sex offender residence check through the NLR Police Department, according to their rules and procedures, to determine if a Level 3 or Level 4 registered sex

offender resides within 2,000 feet of the proposed site for the daycare center/home daycare facility.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It is hereby found and determined that the special use of the above-described lands to allow a daycare center, as provided for herein, will not be detrimental to or interfere with other occupants in the area, and is immediately necessary in order to insure the proper and orderly growth of this land and the proper and orderly growth of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.





Zoning Map




